




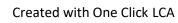

ABOUT THE MANUFACTURER

RS Ecosaver AB is a Swedish company that contains and produces insulation under the brand iCell. iCell has been one of Sweden's largest biobased insulation products since 2010. The company's main purpose is to produce insulation against heat and cold from recycled newspapers that can contribute to a better and healthier indoor climate.

PRODUCT DESCRIPTION

iCell cellulose insulation are manufactured by recycled newspaper and made for thermal and sound insulation in building construction with additives. The Blown-In Insulation can be used in attics, floors, pitched cavities, vertical cavities, sprayed wall applications. The considered service lifetime is 50 years

Functional unit / declared unit: Thermal insulation of 1 m^3 with iCell Loose wool, with a lambda value of 0,039 W/mK, with a design life span of 50 years, for different applications.

Description of system boundaries: Cradle to grave

Cellulose thermal insulation is composed by sorted paper and newspaper with additives. Raw materials transport is considered, mainly truck transport. The raw materials are added in the manufacturing stage, electricity and fuel consumption are considered. The product is packed and distributed to the final client; distribution transportation is volume based. Installation is considered for loose fill cellulose insulation, as blowing the product. The product has 50 years lifespan, and it is assumed 100% recycled at its end of life.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

iCell loose fill insulation is manufactured from recycled newspapers, during the process through the shredder and mills a fire and growth to mould retardants are added. The final product are packed in a polyetenbags of approx 14 kg and delivered on reusable pallets of 24 bags per pallets. Waste production in manufacturing is dust from the mill.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

iCell loose fill insulation will be delivered to the construction trade or the construction site with trucks or trailers. The trucks are loaded with 48 pallets and the trailers are loaded with 33 pallets. The average distances for transport of the insulation to constructions site or trade is about 450 km one way.

iCell loose fill insulation is applied by a blow machine. The installer decides the best method for the object at the moment. At the installation moment there will be no waste of material. Packaging waste that is generated and its treatment is considered in installation process in calculation.

PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase. Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

Currently, cellulose insulation is handled as landfill just like mineral wool in Sweden after it has been assembled.


However, iCell can reuse disassembled loose wool in its production of cellulosic sheets. Therefore, iCell, together with recycling companies in Sweden, is investigating the possibility of collecting dismantled insulation for reuse.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.
